WHY NFHP FORMED?



National Problem

Significant declines in quantity & quality of aquatic habitats required to sustain productivity of fish & aquatic organisms (freshwater, estuarine & marine) nationwide

(highlighted by the Sportfishing and Boating Partnership Council in early 2000s)



National Problem (continued)

Despite thousands of governmental, non-governmental, private, & other watershed/aquatic habitat conservation programs/initiatives/actions supported by billion plus annual funding, **unable** to effectively keep pace with population growth/development to prevent & reverse habitat degradation across boundaries & jurisdictions



Solutions Approach

Sportfishing and Boating Partnership Council (SFBPC) hosts nationwide stakeholder meetings to better define scope of problems & pathway to solutions (~2002-2004)



SFBPC STAKEHOLDERS MEETINGS RESULTS

Identified silo dilemma characterized by insufficient multi-jurisdictional coordination/awareness combined with redundancies for implementing aquatic/fish habitat based conservation programs & actions with existing dollars (watershed/landscape/species range/habitat types, etc.):

- National, regional, & local scales
- Federal, state, tribal, local, other governmental, non-governmental, private, academic, & other stakeholders
- Within same entity

as illustrated in the next slide.



Stakeholders Meetings Summary (continued)

Conceptual Watershed to Illustrate Coordination **Issues/Challenges**: Colored dots represent different entities* who independently collect the same or different data; execute conservation actions within different, or the same portions of freshwater, estuarine, & marine habitats. Activities are typically limited by an entity's legal/administrative jurisdictions, its land ownership boundaries, priorities, & funding sources, etc. (without internal & external coordination). Approach rarely includes comprehensive system needs assessments/actions. RESULTS: redundancies, cost inefficiencies, & limited beneficial habitat data & science-based conservation outcomes at landscape scales.

PROPOSED REMEDY

Develop/implement a national fish habitat action plan by mimicking the successful 1980s North American Waterfowl Management Plan model & resulting North American Wetlands Conservation Act (NAWCA) to conserve waterfowl habitat & populations through coordinated actions*

Resulting Actions (Highlights)

- Association of Fish & Wildlife Agencies (AFWA) Fisheries & Water Resources
 Policy Committee (FWRPC) established the National Fish Habitat Initiative
 (NFHI) Core Workgroup to take lead crafting a National Fish Habitat Action
 Plan, NFHAP (2004)
 - See pages Exhibit 5, pp. 26 & 27 NFHAP (2006 edition) for primary contributors

- Multistate conservation grant projects acquired to fund plan development by the NFHI Core Workgroup & to support pilot on-the-ground habitat conservation projects (~\$2 million, 2004, 2005).



Related Actions (examples)

 National Fish & Wildlife Foundation, in partnership with Bass Pro Shops, pledge funds & align grant-making support for NFHAP development (emphasizing on-the-ground science-based coordinated innovative fish habitat conservation action priorities & approaches)



- Sportfishing and Boating Partnership Council collaborates with a variety of industry, governmental & non-governmental groups, & other stakeholders to establish & expand a partnership coalition (300+)* to support NFHAP development & implementation





Basis for the Interagency Operational Plan: PL 116-188, Title II, Section 208



Interagency Operational Plan, IOP*

(Established by PL 116-188, Title II, Section 208)

- USFWS Director (lead). Core agency representation/participants include NOAA, USEPA, USGS, and USFS & includes other appropriate federal partner entities (see also federal caucus background)
- Intended to establish coordination plan among relevant federal agencies to support & facilitate implementation of NFHP
- Initial IOP version produced 2021, updates required every 5 years

Reflections - Primary NFHP Challenge: Know its Origins & Past:

- NFHP is still in its Infancy (~24-years of history, evolution, & still maturing).
- NFHP 2020 enabling legislation (PL 116-118, Title, II) is only 4-years old.
- Like everything else, NFHP is subject to passage of time that can result in losses of institutional history & knowledge.
- As noted by Robert Boyles, NFHP Chair, NFHAP & the ACE Act are respectively analogous to the constitution & resulting laws.
- -There are no substitutes for carefully reading the 2006 & 2012 NFHAP editions & PL 116-188, Title II.
- NFHP was never intended for those with an assembly line mentality, or for those who support working in silos.
- Improve the wheel don't reinvent it.
- Periodically assess & clarify NFHP related roles, expectations, & capacities of the Association of Fish & Wildlife Agencies & Regional Associations.
- Periodically assess & clarify NFHP related roles, expectations, & capacities of the FHPs, Board, & Partners (not just FHPs).
- Periodically assess NFHP performance by, & contributions from, all NFHP participants, not just FHPs.
- Facilitate improved NFHP networking and the capacity (providing adequate resources) to do so.
- Fully implement the Federal Caucus, aka the IOP, as envisioned in both NFHAP editions. This concept is universal.
- Fully implement NFHP scientific & technical support provisions using the \$2 million authorization (Section 206, ACE Act).
- Rationale for Alaska and Lower 48 states Tribal Board seats.
- Water conservation elements rationale.
- Recognition of NFHP founders & other past contributors at 20th Anniversary of the 2006 NFHAP?
- REMINDER: NFHP was created to facilitate & support improved cost-effective coordination of ALL relevant governmental (federal, state, local, tribal), NGO, private, etc. habitat conservation programs/actions (at local, regional, & national scales) augmented by NFHP administered FHP habitat science-based landscape voluntary conservation habitat actions.
- There are no NFHP implementation silver bullets and short cuts, or there would be no need for NFHP.
- Why participate? Personally rewarding making a difference.
